Brief description of the project	<p>Bumb'INGOMSO – isiXhosa for 'Mould the future' – is a multi-faceted HIV-prevention project that combines behavioural, biomedical, social and economic interventions to inspire, support and motivate adolescent girls and young women to reduce high-risk behaviour and make healthy life choices. The overall goal of the project is to halve the incidence of HIV among vulnerable groups, particularly young women aged 15–29, at Buffalo City Metropolitan Municipality (BCMM) and Amathole District Municipality (ADM).</p> <p>After 7 years of implementation, bumb'INGOMSO is looking for consulting services for the end-line evaluation of the bumb'INGOMSO project. The aim of the end-line evaluation is to explore whether, and to what extent, the project has achieved its intended outcomes and to understand how and why these outcomes were, or were not, achieved.</p>
